California State Budget Act

In October 2020, Governor Newsom issued Executive Order N-82-20 calling for California to conserve 30% of its lands and coastal waters by 2030 to protect biodiversity, mitigate and build resilience to climate change, and expand outdoor access for all Californians. Since then, the California Natural Resources Agency released its Pathways to 30x30 strategy document and has been working with the 30x30 Partnership to implement the 10 Pathways presented in the strategy. To get started with implementation, California has made unprecedented investments that will support the 30x30 initiative. The 2022–2023 California State Budget Act committed S668.7 million this fiscal year to nature-based-solutions programs to support 30x30 across the state. This presentation reviews those investments.

CDFW Grant Programs

In 2022, the California Department of Fish and Wildlife's new Restoration Grant Program announced the availability of S200 million in new funding opportunities. This funding supports various initiatives, including emergency drought funding for protecting salmon against drought and climate change. Funding for projects Addressing Climate Impacts and Nature-Based Solutions initiatives provides support for projects addressing water and habitat impacted by climate change, as well as restoring wetlands and mountain meadows, and creating wildlife corridors. This funding also supports key initiatives including conserving 30% of California's lands and coastal waters by 2030, while increasing the pace and scale of projects through the Cutting Green Tape Initiative. This presentation reviews those funding opportunities.

Funding 30x30: Bonds & Coalitions

California's goal to protect 30% of lands and waters by 2030 (30x30) means critical investments must be made to fund biodiversity, build climate resilience, and improve equity/access. Funding projected in the last state budget included a down payment toward achieving 30x30. The May Revise of the California budget shows significant cuts to these investments. Where does this leave us? Legislation is under consideration to codify 30x30, advocates are working diligently to support additional investments and there is a new bond being considered. This presentation will highlight the intersection of the California budget and budgeting process, with 30x30, the proposed bond, and the work of coalitions advancing 30x30.

Conservation & Climate Funding Programs

As the climate crisis becomes tangible to more people throughout the country, especially in underserved communities hardest hit by rising temperatures, erratic and powerful storms, and underinvestment in better and more equitable access to the outdoors, the need for dedicated funding conservation and natural climate solutions at all levels of government is acute. This presentation will highlight the varied efforts and mechanisms for public funding at the state and local levels; the tools necessary to lead or support ballot measures and statewide legislation; and how the Trust for Public Land's conservation finance program supports conservation and climate funding at every level of government.
