

Pathway #2 - Executing Strategic Land Acquisitions (Urban Focus)

Pathway #8 - Maximizing Conservation Investments

Gabrieleño Band of Mission Indians - Kizh Nation and Laboratory of Indigenous Knowledge Systems (LINKS)

Matthew is an enrolled member of the Gabrieleño Band of Mission Indians – Kizh Nation and has served as Tribal Biologist since 2010. Matthew has been designated by his Tribe to possess and share Kizh-Gabrieleño cultural knowledge and practices taught to him by Chief Ernie P. Teutimez-Salas along with Elders of the Kizh-Gabrieleño Tribe. Mr. Teutimez received both his Bachelor of Science and Master of Science degree in Biology from California State University, Long Beach and is the Tribe's specialist in ethnobotanical and cultural uses of native plants and animals including the prehistoric distributions of natural resources throughout the ancestral territory of the Kizh-Gabrieleño Tribe.
